

Appeal and Re-Determination Process

Introduction to Re-Determinations and Appeals

These will occur when there is a dispute about the fees paid by the Litigator Fee Team (LFT). All requests for re-determination must be sent in writing to the LFT who will record your request and the decision on your request for re-determination on the CCLF online system. Please refer to the LGFS Guidance document for more information about the re-determination and appeals process.

The first stage of the process is to ask the LFT to review the decision (the request for re-determination). If the dispute continues, an appeal may be passed to the Costs Judge for a decision.

View An Appeal

To view an appeal:

1. Search for the relevant **case**.
2. Go to the **Summary** screen to view the payments.
3. The Appeal will be shown directly underneath the payment it is connected to. It is given a **new Bill ID** with the letter **A**. The **Payment Stage** is shown as **NCT Appeal** or **Costs Judge Appeal**.

In the example above, the solicitor has received an Evidence Provision Fee payment of £45.00 (bill id 295290).

Payment has been authorised but the solicitor has disputed the payment amount, seeking a payment of £90. The LFT have recorded the request for re-determination and this is shown as Bill ID 295565(A).

The LFT have authorised the re-determination and therefore the additional payment of £45.00 is displayed in the Payment Amount column.

- Click on the **View** button for Bill ID 295565(A) to view the re-determination reason (shown on system as “Appeal Reason”) and decision reason.
