

Procurement Plan for Redcar & Cleveland

Procurement Summary

1. Family Services

We intend to invite bids for approximately **1,580** new matter starts (NMS) for the provision of face-to-face Family advice within the procurement area (PA) of Redcar & Cleveland.

Clients currently have good access to the range of family public and private services across this PA. To maintain this good access to services we will therefore advertise these tenders as **Service Specification A**.

- Providers will be required to tender for both the full range of private family work and public law children work.
- Providers will need to have a permanent presence in the PA.
- Providers will be required to tender for and undertake a minimum of **100** Legal Help cases and **5** public law certificated cases per year.

Providers who wish to undertake only work for children will be able to tender for a specialist children contract, with no requirement to undertake the full range of family services.

2. Family and Housing (Combined Service)

We will set aside a small proportion of the available NMS in Housing for providers wishing to deliver a combined Housing and Family service.

There has previously been very limited demand for this service combination in the PA and we therefore intend to make **100** Housing NMS available to be provided in this service combination.

Providers wishing to provide Housing as part of this service combination will be required to tender for and undertake a minimum of **50** Housing NMS per year.

3. Social Welfare Law Services

We intend to invite tenders for **750** NMS across the core Social Welfare Law (SWL) categories of Housing, Debt and Welfare Benefits, **100** in Community Care and **100** in Employment.

Housing advice is limited in the PA and there is no permanent location for clients to access Housing or Welfare Benefits services. We have previously had difficulties in placing a sustainable, integrated service in the PA. We will therefore invite tenders under **Service Specification B** and will set the minimum NMS requirement at the lower level of **50**.

Housing, Welfare Benefits and Debt will be advertised together and providers will be required to both tender for and provide services in all three categories.

- Providers may bid to deliver Debt, Housing and Welfare Benefits either as a single legal entity or as part of a consortium.
- Housing, Debt and Welfare Benefits providers will be required to have a permanent presence in the PA and in the access points tendered for.
- Providers delivering Housing, Debt and Welfare Benefits will be required to undertake a minimum of **50** NMS in each category per schedule year.
- Providers delivering Community Care will be required to undertake a minimum of **20** NMS per schedule year.
- Providers delivering Employment will be required to undertake a minimum of **30** NMS per schedule year.
- Community Care and Employment providers will be required to have a part-time presence in the PA.
- As SWL tenders are invited under **Service Specification B**, the requirement to employ an authorised litigator in Housing and/or Community Care will **not** be an essential criterion. However, where a competitive process is necessary to decide between bids, as part of the selection process we will prefer providers who can provide the best access to an authorised litigator. This might mean giving preference to those with an employed authorised litigator. We will also consider alternative arrangements but providers are advised that this may score lower in the ranking.

For Debt, Housing and Welfare Benefits, we will divide the available NMS for the PA between the three categories as follows:

4. Access

There are no potential access issues within Redcar & Cleveland as the area is geographically small and good public transport links are available across the whole of the PA. Therefore no additional criteria will be used to select providers on the basis of their location within the area and providers will only be required to have a permanent presence within the procurement area.

5. Budget

Current spend in this area is higher than that which we would expect to spend in Family services according to the Indicative Spend Budget Model. It is therefore unlikely that we would wish to actively increase the provision of Family services and matter starts will be carefully managed with the aim of remaining within the level of current spend.

Current spend in this area is lower than that which we would expect to spend in SWL Legal Help according to the Indicative Spend Budget Model. Therefore, the total number of NMS available in this area will be increased from that which is currently being delivered to enable an increase in access to services which moves closer to that suggested by the Model.
